

When to use this form

Use this form if you are applying for further loan payments under the Aust alia App e ti eship Suppo t Loa s program ('opt-in request').

You may only use this form if you had a Aust alia App e ti eship Suppo t Loa application approved previously.

If you have not successfully applied for Aust alia App e ti eship Suppo t Loa s previously, you must complete and submit a Aust alia App e ti eship Suppo t Loa s Application (form 1289). You can get a copy of form 1289 from your Apprenticeship Network Provider.

Confirming your identity

You must ensure that the information you provide in your opt-in request is correct and matches the information the Australian Taxation Office (ATO) holds about you. If the ATO cannot identify you, you may not receive Aust alia App e ti eship Suppo t Loa payments.

The easiest way to check and update your details is through myGov. MyGov is a simple and secure way to access a range of government services online with one username and password. To check your details, access your ATO account at my.gov.au, and then select 'update contact details'. Alternatively, you can call the ATO on 13 28 61.

How to lodge your opt-in request

You must complete this form and return it, along with any supporting documentation, to your Apprenticeship Network Provider. The completed form must be returned in person, by mail or via email (preferred).

What is a Australian Apprenticeship Support Loan?

A Australian Apprenticeship Support Loan can help you pay for your everyday living expenses while you undertake your apprenticeship or traineeship. It is an government funded loan that is paid in monthly instalments for up to six months at a time. Your debt is indexed annually which means the amount you repay in total will be more than the original amount of the loan.

You will get a 20 per cent discount on your debt when you have successfully completed your apprenticeship.

Please refer to the 'Australian Apprenticeship Support Loans – at a Glance' fact sheet for details, including payment rates. You will start repaying your Aust alia App e ti eship Suppo t Loa once you have reached the minimum repayment threshold. You should think about how this will affect you in the long-term before you apply. If you have any queries regarding loan repayments, please call the ATO on 13 28 61.

Who can receive further payments?

You may qualify for further loan payments under the Aust alia $App\ e\ ti\ eship\ Suppo\ t$ Loa s program if:

* you have successfully applied for Aust alia App e ti eship Suppo t Loa previously,

st you continue to undertake an apprenticeship în an occupation or towards a qualification

What if my circumstances have changed?

When completing this form you must either

- confirm that your circumstances have not changed, or
- notify your Apprenticeship Network Provider of any changes to your circumstances.

You must notify your Apprenticeship Network Provider within 14 days if:

- you cancel, suspend or withdraw from your apprenticeship
- you change your employer
- you change your qualification
- your workplace address changes (if you are working in the horticulture sector)
- your Tax File Number (TFN) changes
- your Australian residency status changes
- you are currently (or about to be) imprisoned
- ullet anything else changes that may affect your eligibility to receive Aust alia App e ti eship Suppo t Loa payments.

These changes are called 'notifiable changes'. If you do not notify your ApprenticeshipNetwork Provider of a notifiable change within 14 days, you may commit an offence and need to pay back the money received immediately.

You should also notify your Apprenticeship Network Provider if your contact or bank details have changed.

Before you apply for further payments

If you are under 18

If you are under 18 years of age, you are encouraged to seek the acknowledgment of a parent or guardian to demonstrate that you understand the responsibilities related to repaying the Australian Apprenticeship Support Loan.

Minors and their parents or guardians are strongly encouraged to read the 'Australian Apprenticeship Support Loans Under 18s' and the 'Aust alia App e ti eship Support Loans under 18s Parent/Guardian' fact sheets. You can get these fact sheets on https://www.apprenticeships.gov.au or from your Apprenticeship Network Provider.

Applying for further payments

If you wish to receive Australian Apprenticeship Support Loan payments beyond the initial six month period, or if you wish for Aust alia App e ti eship Support Loa spayments to recommence, you can apply using this form. Your Apprenticeship Network Provider will make a decision whether you are eligible to receive further Australian Apprenticeship Support Loan payments.

Your Apprenticeship Network Provider must receive your opt-in request before the next payment would be due. Otherwise, you may not receive a Australian Apprenticeship Support Loan payment for that month.

You can lodge further opt-in requests at any time during your apprenticeship.

Completing this form

You are encouraged to complete this form using a PDF application. If you wish, you can sign the declaration by typing your name and return the completed form via email. In that case, please confirm in the body of your email that the electronic signature in the attached form was provided by you.

Alternatively, use black or blue pen. Write in block letters. If you make a mistake, cross out the incorrect information, insert the correct information and initial the change. Do not use correction fluid or white-out.

Supporting documents



You **must provide at least one supporting document** that allows the Apprenticeship Network Provider to confirm your identity, for example a passport, drivers licence, proof of age card or similar ID. The document provided should show your first and last name, a photo and/or current residential address. If you don't have any of the documents listed above, you can provide your Medicare card, bank card, or similar.

You must provide a legible photocopy/scan/photo of the supporting document(s), preferably in colour. You do **not** need to provide certified copies, unless you are requested to do so.

Payments

Australian Apprenticeship Support Loan payments are made monthly in arrears. They can only continue after you have submitted the completed opt-in request form to your Apprenticeship Network Provider and you have been found eligible to receive further Australian Apprenticeship Support Loan payments. Payments cannot be made for previous months.

You will receive up to six Australian Apprenticeship Support Loan payments initially. Payments will be made by direct credit into a nominated bank account. This account must be maintained by you either alone or jointly.

Payments received under the Aust alia App e ti eship Suppo t Loa s program are not classified as income and therefore not subject to income tax.

You can cancel your Australian Apprenticeship Support Loan payments at any time. If you wish to cancel your payments, please contact your Apprenticeship Network Provider.

- have signed and dated the declaration, and
- have attached all supporting documents as necessary (identity).

Unsigned, incomplete or copied forms will not be processed.

What happens next?

Once you have submitted your completed opt-in request form, your Apprenticeship Network Provider will assess your opt-in request and advise you in writing whether you are eligible for further payments under the Aust alia App e ti eship Suppo t Loa s program.

Privacy and your personal information

Your personal information is protected by law (including the *Privacy Act 1988*).

The Aust alia App e ti eship Suppo t Loa s program is jointly delivered by the contracted Australian Apprenticeship Support Network providers (Apprenticeship Network Providers), the Australian Government Department of Employment and Workplace Relations (the department) and the Australian Taxation Office (ATO).

Apprenticeship Network Providers collect your personal information, including your Tax File Number (TFN), to process and manage your Australian Apprenticeship Support Loan application and payments. This information is accessible by the department, and, as relevant to managing your Australian Apprenticeship Support Loan debt, the ATO. Your information may also be used by the department for the purposes of research, statistical analysis and policy development.

The collection and use of your information is authorised under the Australian Apprenticeship Support Loans Act 2014. You are not required by law to provide the information requested in this form, however you will not be able to receive a Australian Apprenticeship Support Loan if you fail to do so.

The department only shares your information with other parties where you have agreed, or where the law allows or requires it. The department's privacy policy, which includes information on how the department handles personal information, how you can access or correct personal information, and how to make a complaint, can be found at http://dewr.gov.au/privacy. Please refer to your Apprenticeship Network Provider for details on their privacy policy.
